

Clinical Policy: Colesevelam (WelChol)

Description

Colesevelam (WelChol[®]) is a bile acid sequestrant. WelChol packet for suspension requires prior authorization.

FDA Approved Indication(s)

WelChol is indicated, as an adjunct to diet and exercise:

- To reduce elevated low density lipoprotein cholesterol (LDL-C) in adults with primary hyperlipidemia (Fredrickson Type IIa) as monotherapy or in combination with a hydroxymethylglutaryl-coenzyme A (HMG CoA) reductase inhibitor (statin)
- To reduce LDL-C levels in boys and postmenarchal girls, 10 to 17 years of age, with heterozygous familial hypercholesterolemia if after an adequate trial of diet therapy the following findings are present:
 - LDL-C remains \geq 190 mg/dL or
 - LDL-C remains \geq 160 mg/dL and
 - There is a positive family history of premature cardiovascular disease or
 - Two or more other CVD risk factors are present in the pediatric patient.
- For the improvement of glycemic control in adults with type 2 diabetes mellitus.

Limitation(s) of use:

- Do not use WelChol for glycemic control in type 1 diabetes or for treating diabetic ketoacidosis.
- WelChol has not been studied in type 2 diabetes in combination with a dipeptidylpeptidase 4 (DPP-4) inhibitor.
- WelChol has not been studied in Fredrickson Type I, III, IV, and V dyslipidemias.
- WelChol has not been studied in children younger than 10 years of age or in premenarchal girls.

Policy/Criteria

Provider must submit documentation (such as office chart notes, lab results or other clinical information) supporting that member has met all approval criteria.

It is the policy of health plans affiliated with Centene Corporation[®] that WelChol packet for suspension is **medically necessary** when the following criteria are met:

I. Initial Approval Criteria

A. Primary Hyperlipidemia (must meet all):

1. Prescribed for lipid lowering;

2. Age \geq 10 years;
3. Documentation supports inability to swallow pills or clinically significant adverse effects to WelChol tablets;
4. Failure of colestipol granules and cholestyramine powder for suspension at up to maximally indicated doses, each used for \geq 3 months, unless contraindicated or clinically significant adverse effects are experienced;
5. Failure of \geq 3 consecutive months of adherent use of a statin therapy, unless contraindicated or clinically significant adverse effect are experienced;
6. At the time of request, serum triglyceride concentrations do not exceed 500 mg/dL;
**Lab should current (drawn within the last 3 months)*
7. Dose does not exceed oral suspension packet of 3.75 grams daily.

Approval duration: 6 months

B. Diabetes Mellitus (must meet all):

1. Diagnosis of type 2 diabetes mellitus;
2. Age \geq 18 years;
3. HbA1c drawn within the past 3 months is \geq 6.5%;
4. Failure of adherent use of a triple anti-diabetic regimen which must include metformin in combination with agents from any of the following classes for \geq 3 months, unless contraindicated or clinically significant adverse effects are experienced:
 - a. Glucagon-like peptide-1 (GLP-1) receptor agonist;
 - b. Sodium glucose co-transporter 2 (SGLT-2) inhibitor;
 - c. Dipeptidyl peptidase 4 (DPP-4) inhibitor;
 - d. Thiazolidinedione (TZD);
 - e. Basal insulin;
5. At the time of request, current (within the last 3 months) serum triglyceride concentrations do not exceed 500 mg/dL;
6. Dose does not exceed oral suspension packet of 3.75 grams (1 packet) per day.

Approval duration: 6 months

C. Other diagnoses/indications

1. Refer to the off-label use policy for the relevant line of business if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized): HIM.PHAR.21 for health insurance marketplace.

II. Continued Therapy

A. All Indications in Section I (must meet all):

1. Currently receiving medication via Centene benefit or member has previously met initial approval criteria;
2. Member is responding positively to therapy;
3. If request is for a dose increase, dose does not exceed oral suspension packet of 3.75 grams (1 packet) per day.

Approval duration: 12 months

B. Other diagnoses/indications (must meet 1 or 2):

1. Currently receiving medication via health plan benefit and documentation supports positive response to therapy.
Approval duration: Duration of request or 12 months (whichever is less); or
2. Refer to the off-label use policy for the relevant line of business if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized): HIM.PHAR.21 for health insurance marketplace.

III. Diagnoses/Indications for which coverage is NOT authorized:

- A. Non-FDA approved indications, which are not addressed in this policy, unless there is sufficient documentation of efficacy and safety according to the off label use policies – HIM.PHAR.21 for health insurance marketplace or evidence of coverage documents.

Appendix C: Contraindications/Boxed Warnings

WelChol is contraindicated in patients with:

- A history of bowel obstruction
- Serum triglyceride concentrations > 500 mg/dL
- A history of hypertriglyceridemia-induced pancreatitis

Appendix E: Statin Contraindications

- Decompensated liver disease (development of jaundice, ascites, variceal bleeding, encephalopathy)
- Laboratory-confirmed acute liver injury or rhabdomyolysis resulting from statin treatment
- Pregnancy, actively trying to become pregnant, or nursing
- Immune-mediated hypersensitivity to the HMG-CoA reductase inhibitor drug class (statins) as evidenced by an allergic reaction occurring with at least TWO different statins
